

#### MAKE CHECK PAYABLE (in US Funds) TO: White Sands Agility Club or (WSAC)

Opening Date: Friday, February 1, 2024, at 8:00am

Closing Date: Closes March 24, 2024, at 8:00 pm. Entry method is First Received.

#### Paper entries received within 24 hours of the opening date & time limit must:

- 1) Include postage or be metered. No hand deliveries in the first 24 hours.
- Be delivered by a multi-state or multi-national postage or carrier service, including but not limited to USPS, FedEx, UPS & DHL. If above conditions are not met, the entries are not valid and must be returned to the sender.
- B) Express mail must be designated "no signature required".

A 100% refund of the entry fee will be given for any bitch that comes into season with written notification from a veterinarian provided to the Trial Secretary.

#### Walk-through & Warm-up

Handlers in all classes in which they are entered are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

#### **CLASSES OFFERED & JUDGING TIMES**

#### Classes Offered

ISC STD and ISC JWW, including the preferred classes, will be offered according to the entry form. (International Sweepstakes Classes will be offered when indicated in the premium and on the entry form). A complete set of rules for all classes is available from the American Kennel Club, 8051 Arco Corporate Drive, Suite 100, Raleigh, NC 27617-3390, or from the AKC web site. It is the exhibitor's responsibility to enter their dog in the correct class. The Trial Secretary cannot make any changes (except for move-ups as noted) after the closing date of the trial. Be sure to check your entry form carefully and make certain you have entered the correct class(es).

<u>Move-ups, Errors, Confirmation Protocols Move</u>-ups after entries close must be submitted to the trial secretary in writing (mail or email) by <u>6 pm, Mountain time, Monday, April 1, 2024</u>. Requests for move-ups over the phone <u>will not be accepted.</u> Day-to-day move-ups will be accepted at the trial. Move-ups must be submitted on the move-up form provided, to the trial secretary no later than 30 minutes after completion of the last class of the day.

#### **AWARDS, RIBBONS AND PRIZE INFORMATION**

Awards for qualifying scores only. All awards must be claimed at the show. Ribbons will be awarded to first through third place in each height division in each class. Special High In Trial cumulative awards for each level.

<u>High In Trial Awards</u> – Dogs who are entered in ALL runs (Friday – Sunday) of a given level (1, 2, and/or 3) are eligible for HIT awards. HIT winners will be determined by the lowest, cumulative score (Time plus faults/SCT). Regular and preferred dogs will be scored separately.

#### **OBSTACLES AND EQUIPMENT**

#### **Obstacles**

Obstacles shall meet the specifications for obstacles in the current edition of AKC Regulations for Agility Trials. There will be no equipment familiarization at this trial. As of 9/1/06 AKC does not allow it.

#### **ELIGIBILITY AND HEIGHT DIVISIONS**

#### **Dogs Eligible to Enter**

This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club or are registerable breeds that have obtained PAL/ILP numbers from the American Kennel Club, except bitches in season, aggressive dogs, blind dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance.

Mixed breed dogs listed in the AKC Canine Partners program are eligible to enter this all-breed AKC agility trial. Mixed breed dogs entered in these events must list the breed name as "Canine Partner" (mixed breed) and not as a breed hybrid and must include their AKC Canine Partners number on the entry form and check the AKC No. Box.

#### **Jump Height Information**

All dogs without height cards will have to be measured by the judge of record, except 24"/24C" dogs. If a VMO or an AKC Representative is available, all dogs without height cards, including 24"/24C" dogs, will need to be measured. When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog has a valid jump height card or if your dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dogs on the *Dogs To Be Measured List*. #### ADDITIONAL SITE INFORMATION

Undercover on dirt with crating space on the sides of the ring. You might consider bringing shade tarps/cloth to attach to the overhang on the sites, or shade tents for outside crating. Very limited nearby crating space from your car is available and priority given to key trial workers. Free parking is available for all exhibitors and spectators. Parking is at your own risk.

Crates may be left overnight; however, the WSAC and/or Power of Dogs will not be responsible for and lost or damaged items at the show site.

**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

There will NOT be a food concession on site, and very limited food options nearby but snacks and a full lunch will be provided for workers.

#### **WORLD TEAM TRYOUT QUALIFICATIONS**

The ISC runs at this event DO NOT qualify for a bye to the World Team Tryouts.

#### COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes in which they are entered are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

#### **RINGSIDE**

**Dogs may arrive** any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

**Judges are not required** to wait for dogs. The owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

#### CATALOGS/RUNNING ORDER

A limited number of catalogs will be available for viewing at the trial secretary booth. None will be sold. Running order sheets will be available to all exhibitors at no charge and posted online after closing.

#### **VENDORS**

Vendors are welcome, with no vendor fee. Please contact the Trial Chairman, Ruth Christopher, at (575) 649-7563 to reserve a spot.

This club does not agree to arbitrate claims as set forth on the Official AKC Entry Form for this event.

**JUNIOR HANDLER DISCOUNTS:** WSAC offers ½ price entry fees for handlers under the age of 18. An AKC Junior Handler number must be included on the Entry Form. To obtain a free Junior Handler number, call the AKC at (919) 233-9767

Handler substitutions can be made before entries close by paying additional entry fees. No handler substitutions allowed after the closing date/time. Refunds will not be given if the assigned Junior is unavailable to handle the dog.

JUDGE Terry Eiger IS NOT A VMO. AKC IS NOW REQUIRING ALL DOGS TO BE MEASURED BEFORE RUNNING IF THEY DO NOT HAVE A PERMANTENT OR TEMPORARY HEIGHT CARD. IT IS THE EXHIBOTOR'S RESPONSIBILITY TO GET THEIR DOGS MEASURED.

#### **MEASURING and HEIGHT CARD INFORMATION**

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

#### NEW SIMPLIFIED JUMP HEIGHT CARD PROCESS

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the box so that the Trial Secretary knows whether to include your dog on the Dogs To Be Measured List. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is

allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

#### **Entering for Exhibition Only (FEO)**

FEO allows exhibitors to work with their dogs in a trial environment. FEO is only offered in the Time 2 Beat and FAST classes. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring. Toys must be non-audible and may not leave the handler's hand. Toys that roll freely may not be used.
- · Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time (Reminder: This section only needs to be published in the Premium List if the Club is offering FEO.)

#### Fix and Go On

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run

#### **EXHIBITOR INFORMATION**

#### **Important Information for Exhibitors**

- All owners and handlers are responsible for correctly entering and participating in this trial in accordance with AKC rules. Owners are responsible for errors in entry forms, regardless of who may make such errors.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. AKC does not permit pinch/prong collars, electrical or special training collars anywhere on the trial grounds.
- ➤ The safety of dogs is of primary concern. By entering the trial, exhibitors acknowledge that they are familiar with the rules and regulations of the AKC agility program, and that their dogs are familiar with and able to perform all obstacles safely.

- Confirmation of entry and a schedule of judging time will be sent to the address (email will be used when provided on the entry form) on the official AKC entry form after the closing date. If an exhibitor has not received a copy of the schedule at least seven days prior to the show, the trial secretary should be contacted. Returned checks do not constitute a valid entry. If a check is returned, the entry will be deemed invalid, and the issuer will be billed for all trial associated fees, including, but not limited to: AKC fees, judges fees and secretarial fees. <a href="Envelopes/transactions containing entries for more than the ten (10) dog maximum shall be treated as an invalid entry.">Envelopes/transactions containing entries for more than the ten (10) dog maximum shall be treated as an invalid entry.</a>
- Conditional, unsigned, incomplete, illegible, telephone or telegraph entries cannot be accepted. Entries not on official AKC forms or photocopies of AKC forms without the agreement form included are not acceptable.
- 100% of entry fees will be refunded if a written request is received by the trial secretary on or before the trial closing date. After closing, refunds will be given, if notification is received not less than 48 hours prior to the start of the trial, less all fees, for injured or ill handlers, injured or ill dogs. Bitches in season will receive 100% refund. No refunds will be given if request is received after the published commencement of the trial. Verification from a doctor or vet may be required at the club's discretion. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, acts of God, public emergency, acts of public enemy, or any other cause beyond the control of the organizing committee.
- White Sands Agility Club and Power of Dogs assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or spectators, or to any of their dogs or property, and further assumes no responsibility for injury to any child not under the control of his or her parents or guardians.
- WSAC and/or Power of Dogs may cancel this event in extreme weather conditions.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made. All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.
- Please clean up after your dogs while on the show grounds and at the motel site. We want to retain these facilities for future events.
- Only dogs that are eligible to be shown under the AKC rules shall be allowed within the show precincts.

DIRECTIONS TO SHOW SITE: From I-10 (from Las Cruces or El Paso) take Vado Exit 155 for NM 277 towards Berino/Vado heading west. At the roundabout on the west side of I-10 take the second exit (west) onto NM 277 for 1.5 miles. At the stop sign, turn left onto NM 478 (south) for 700ft. Then turn right onto NM 189 (west) for 1.5 miles (you will cross the railroad tracks and the Rio Grande). At the stop sign, you will turn left onto NM 28 (south) for 2 miles. You will then turn left onto Afton Road and the destination is 0.60 miles on your left. 573 E Afton Rd, La Mesa, NM 88044. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. #### INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24 -choice height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners<sup>SM</sup> program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?

# **Common ISC Questions:**

- Who can enter ISC? Anyone who wants to try it. There are no restrictions on what levels you enter in ISC and how many classes you enter on a single day. If you want to enter all Agility 1, Agility 2, Agility 3, Jumping 1, Jumping 2 and Jumping 3 you can.
- Does my dog have to jump at international jump heights? No, you can enter your dog in regular or preferred at the height they normally jump in AKC
- > Can I train in the ring? Yes. At an ISC only event, you can run each class as FEO (For Exhibition Only), just as you can with T2B and FAST in regular AKC trials. You may also use Fix and Go On in each class, just as you can in all other AKC classes.
- ➤ How do ISC courses compare with other AKC courses? ISC courses generally have more space between obstacles than other AKC courses. Most ISC courses designed by FCI judges have really nice flow for the dogs but can be challenging for the handlers. In general, ISC level 1 courses (Agility 1 and Jumping 1) have about the same level of difficulty as AKC Open courses. ISC level 2 courses (Agility 2 and Jumping 2) have about the same difficulty as AKC Ex/Master courses but may include some Premier elements. In general, ISC level 3 courses (Agility 3 and Jumping 3) are more difficult than courses offered in regular AKC trials. Some examples of the three levels of ISC Agility courses are shown on this page.
- How is ISC judged? ISC is judged using FCI rules. A summary of the scoring system is included in Chapter 14 or the "AKC Regulations for Agility Trials, Non-Regular Agility Classes International Sweepstakes Class".
- ➤ How are the runs scored? Faults, then time
